

## Golden Ticket Competition 2017 Terms and Conditions

These are the official Golden Ticket Competition 2017 terms and conditions for participating in the competition conducted or promoted by or in association with PVPRO Limited (“PvPRO”).

1. The promoter of this Golden Ticket Competition (“Competition”) is PvPRO Limited, a Cyprus corporation, located at 6 Dimostheni Severi Str. Presidium Building, Apartment 22, 1080, Nicosia, Cyprus, (the “Promoter”).
2. Information on how to enter and on the Prize form integral part of these conditions of entry (the “Conditions of Entry”). Entry into this Competition and/or acceptance of the Prize as defined below (in the event that you win the Prize) constitutes your binding acceptance of the terms and conditions and the Conditions of Entry, on behalf of yourself.
3. The Competition is free to enter and no purchase of any kind is necessary. By entering the Competition, Entrants accept and will be bound by these terms and conditions (“Terms”) as well as the General Rules (<https://www.pvpro.com/pvpro/termsAndConditions>). In case of any conflict or discrepancy between these Terms and the General Rules, these Terms shall prevail.

### Terms of Participation

4. Entry is free and open to residents of Europe and North America aged 18 years or over, who fulfil in whole the competition requirements as specified below and on the website [www.pvpro.com](http://www.pvpro.com).

To enter the Competition, Entrants must complete any of the following three (3) options during the Competition Period:

- a) Visit the PvPRO© website at [www.pvpro.com](http://www.pvpro.com) and create a free account, by submitting the required information (username, password, e-mail address) and verifying the email address and linking a Steam account. Click on the “Join Free” button of the giveaway, at the top left corner of the site, and play ten (10) games in their region. Each Entrant may enter the competition from one (1) region. [Requirements: Account with PvPRO, Linked Steam account with PvPRO, Ownership of Counter-Strike: Global Offensive in Steam library],
- b) Refer two (2) persons, who will have to register on [www.pvpro.com](http://www.pvpro.com) with the given RAF code (which is in fact the referee’s username). Those persons must have a Steam account with an original CS:GO copy registered and fully complete their registration by verifying their e-mails as well. All parties (the referee and the 2 persons) are reminded to have their profiles set to public.
- c) Share the Twitter and Facebook posts, which have been designated on our website [www.esgtour.com](http://www.esgtour.com). Retweet on Twitter <link of the post> and share on Facebook <link of the post>. In order for this entry to be successfully registered, the Entrant will have to send an email to [info@pvpro.com](mailto:info@pvpro.com) with an attached screenshot of the Retweet and Share from their respective accounts.

Completing any of the above mentioned three (3) options marks the Entrant as eligible for the Competition. It is underlined that in case more than one of these actions are executed, then more entries are recorded for the Competition, increasing the Entrant’s chances to win the Competition.

The Promoter shall notify the Winners of their selection by e-mail to the e-mail address linked to its PVPRO account or to the email submitting the actions on Twitter and Facebook within one week of the Closing Date.

5. All full entries will be automatically recorded for a chance to win the Prize of a trip to watch the the ESG Tour | Mykonos 2017 live that will be held that will be held in Mykonos, Greece from September 7<sup>th</sup>, 2017 to September 11<sup>th</sup>, 2017, with all the travel, accommodation and catering expenses paid for by the Promoter, as defined below under 12.
6. There will be only two (2) winners (“Winners”). The two (2) Winners will be determined through a random number generator function from the proprietary software of PvPRO LTD.

7. The Competition is not open to:
  - a) directors, members, partners, agents, employees, consultants, associated companies of the Promoter or any supplier of goods or services in connection with the Competition or anyone else professionally connected with the Competition; and
  - b) the spouse, life partner, business partner or associate, or the natural or adopted parent child, or sibling, of any of the persons specified above.

9. The Competition is open for entries on August 7<sup>th</sup>, 2017 at 15:00 (CEST) ("Opening Date") and closes on August 21<sup>st</sup>, 2017 at 23.59 (CEST). The period from the Opening Date up to the Closing Date included shall be referred to as the "Competition Period". The Promoter reserves the right to vary, suspend, extend, or reduce the duration for a valid reason, provided that the change will be published in this page <http://esgtour.com/golden-ticket/>. The Promoter also reserves the right to modify the terms of the competition (including but not limited to the Conditions of Entry) as well as cancel the competition or the Prize, or any aspect thereof for any reason which the Promoter deems necessary in its opinion or if circumstances arise outside its control and inform the public on the aforementioned page.
10. Entrants can only enter with their own RAF code. The Promoter reserves the right to request proof of residency at the stated address and identification for verification (to the Promoter's satisfaction in its discretion) before issuing the prize. Incomplete or incomprehensible entries will be deemed invalid. The Promoter's decision to disqualify an entry is final and no correspondence will be entered into. No responsibility will be taken for lost, late or misdirected entries.
11. The Winners cannot make the trip in conjunction with any other supplier or travel agency.
  - (ii) The airline Company, airline tickets and accommodation will be informed by PvPRO LTD and depends on availability.
  - (iii) The airline company, airline tickets and accommodation are selected by PvPRO LTD and the Winners are obliged to accept them. If the Winners want to choose another airline company, airline tickets or accommodation, any additional costs will be charged to them. In the event that the prize notification email is returned as undeliverable, such Prize will be forfeited and an alternate winner will be selected from all remaining (non-winning) eligible entries. Names of the winners (first name, last name and city) may also be announced in further promotional communication from PvPRO.

16. You agree that your participation in the Competition, and your acceptance and/or use of the Prize, or any aspect thereof, is at your own risk.

The Promoter will not be liable, and disclaim any and all liability, for any loss, liability, expense or damage (including but not limited to direct, indirect, incidental, punitive or consequential loss) of any nature whatsoever which is suffered or for any personal injury (including death), whether arising from negligence or any other cause, which is suffered or sustained in connection with Entrants' participation in the promotion and Competition and/or related to the prize (either to the acceptance of the prize or the use thereof), or by any action taken by the Promoter in accordance with the terms and conditions, except for any liability, which cannot be excluded by law (in which case such liability is limited to the maximum extent allowable by law). organising, assessing, publishing and conducting the Competition, always within the framework and conditions of the applicable Cyprus law. In connection with this database, the Entrants have the right to have access, correct, delete or file a complaint in regards with the data related to them.
